**(Closed Monday, Wednesday & Friday)**

Permits are required for all vehicles using the Transfer Station and must be attached to the lower passenger side of the windshield.

Be prepared to show your vehicle registration and proof of Ludlow residency when you purchase your Transfer Station Permit.

Permits may not be transferred between vehicles.

Residential (includes 52 Town logoed disposal bags).....	\$25.00
Additional Residential.....	\$10.00
Residential Replacement Permit (for any reason).....	\$10.00
Business (permit fee plus \$0.10 per pound).....	\$75.00
Additional Business (permit fee plus \$0.10 per pound).....	\$50.00
Commercial (permit fee plus \$0.10 per pound).....	\$125.00
Add'l Commercial (permit fee plus \$0.10 per pound).....	\$75.00

## LUDLOW TRANSFER STATION PERMIT RULES

Residential permits and Town approved colored-residential bags can be purchased at the Transfer Station or inside the Municipal Office.

Business and Commercial Permits may only be purchased directly at the Transfer Station.

Please be prepared to provide your vehicle registration and verification of property ownership or a copy of your lease/rental agreement.

To obtain a permit to use the Ludlow Transfer Station you must comply with the following requirements:

**RESIDENTIAL PERMIT:** Must be a homeowner (or rent) in the Town/Village of Ludlow.

**Residential Proof Accepted:** Voters check list  
Grand list  
Lease or rental contract (if renting in Ludlow)

**BUSINESS PERMIT:** Must be a business domiciled in the Town/Village of Ludlow.

**Business Proof Accepted:** Voters check list  
Grand list  
Lease or rental contract

**COMMERCIAL PERMIT:** Must be a Ludlow domiciled business or service Ludlow residents or businesses.

**Commercial Proof Accepted:** Grand list  
Voter's checklist  
List of customers serviced in Ludlow

**IMPORTANT:** If you are a valid 2023/2024 permit holder and borrow someone else's vehicle (truck) for disposal, you must bring your permitted vehicle along with you to the Transfer Station.

**Please note:** Occasional non-permitted vehicles (2-3 times per year) will be charged \$3 per 33-gallon bag or \$0.10/lb. at the Transfer Station manager's discretion. There is no fee for Recycling.

**SWAP SHOP RULES:** Please check with a staff member before placing items in the Swap Shop.

**APPEAL PROCESS:** Any person or business may appeal the above requirements, first to the Municipal Manager, and then to the Ludlow Select Board.

### LUDLOW TRANSFER STATION FEE STRUCTURE:

1. All identified residents/taxpayers of the Town/Village of Ludlow will purchase a Transfer Station sticker for a primary vehicle and will receive 52 transfer station logoed bags to be used for trash disposal.
2. Additional vehicles may be included for a fee (no additional bags will be issued).
3. Additional bags may be purchased in 26 bag rolls for \$25.00.
4. Mandated Recyclables may be comingled loose and disposed of "For Free" in the designated Transfer Station container.
5. Stickered Residents with disposal anomalies may go over the scales at \$0.10/pound with a \$5.00 minimum charge.
6. Business/Commercial users will continue to use the scales for trash and C&D at \$0.10/pound. Individual certifications will be required that mandated recyclables are being disposed of in accordance with ACT 148. Minimum charge of \$5.00.

**Please Note: Scale will close promptly at 4:45 PM daily.**

Other disposal items will continue at the published rates and may be modified by the Ludlow Select Board.

### RECYCLING AT THE TRANSFER STATION

**Placing unacceptable items in our container will render the entire container load unacceptable for recycle!**

1. Mandated recyclables will be dealt with on a hybrid-single stream basis. This includes aluminum and steel cans, aluminum foil and pie plates, plastics #1 and #2, cardboard, boxboard, all paper products. Everything can be co-mingled with the exception of glass and corrugated cardboard (please keep separate). All recyclables must be clean and dry and please remove and discard caps and lids.
2. Cardboard and boxes must be flat (no pizza boxes with food debris).
3. Mixed Paper is almost anything - Newspapers, magazines, most thin, single-ply containers such as cereal boxes, catalogs, junk mail, office paper, paper bags, paperback books, books (hard covers removed and discarded). Please, **no** plastic wrappers, waxy soap or frozen food containers, milk or juice cartons, tissue paper, wrapping paper or paper towels.
4. E-Waste Vermont's Electronic Waste law **Please see a staff member prior to disposal** - provides for the free and convenient collection of computers, TVs, printers, monitors and peripherals (keyboards, mice, etc.) from Vermont households charities, school districts and businesses with up to 10 employees. Other electronic waste must also be recycled, but there is a fee.
5. Batteries: Household batteries are accepted and recycled for free. This includes AA, AAA, C, D, 9V, hearing aid and watch.
6. Residential trash will **only be accepted** in "Town of Ludlow Transfer Station" logoed bags except as provided in the fee structure outlined below in order to comply with the ACT 148 "pay to throw" provision. Residential trash in non-logoed bags will need to weighed and will be charged \$0.10 per pound (\$5 minimum charge).
7. Food Scraps – **Only bones and meats will be allowed in the MSW purple logoed bags**. All other food scraps, coffee grounds, ashes, flowers, etc. will be allowed at Compost Station. When in doubt, please ask a Transfer Station Attendant.

## TRANSFER STATION DISPOSAL FEES

EFFECTIVE JULY 1, 2023 TO JUNE 30, 2024

PLEASE BE SURE TO CHECK-IN WITH A STAFF MEMBER PRIOR TO UNLOADING.

This facility DOES NOT accept any type of hazardous waste or toxic materials.

**Bamboo IS NOT accepted.**

**ALL APPLIANCES:** \$15 each (includes refrigerators, stoves, washers, dryers, hot water heaters, furnaces, air conditioners, freezers or anything with Freon)

**BATTERIES:** \$5 each for lead acid (automotive)

Cell Phones, Hearing Aids, Alkaline and ni-cad batteries – no charge (anything rechargeable)

**BRUSH:** \$0.10 per lb. for any/all brush for residents, businesses & commercial. **Bamboo IS NOT accepted.**

**CONSTRUCTION / DEMOLITION:** \$0.10 per lb. (wood, sheet rock, tiles, shingles, insulation, etc.). Clean wood must be separated. **Please see Attendant prior to unloading.**

**BALLASTS (ELECTRICAL):** \$3 each

**E-WASTE DISPOSAL:** Please see the Transfer Station staff (computers, monitors, TV's, printers before unloading)

**FIRE EXTINGUISHERS:** \$5 each

**FLUORESCENT BULBS:** NO charge

**FURNITURE:** \$0.10 per lb. (vehicles must go over the scale)

**MATTRESS / BOX SPRINGS:** \$10 each for twin or full size (2 or more \$0.10 per lb.)  
\$15 each for queen or king size (2 or more \$0.10 per lb.)

**MIXED SCRAP METAL:** Pipe, lawn mowers, tin roofing, car parts — **no charge!**

**PROPANE TANKS:** \$1 for 1-lb. tanks / \$5 for 20-lb tanks / \$10 for 30 to 100-lb tanks

**RUGS:** \$5 per roll (10' X 10') or \$0.10 per lb. (2 or more)

**TIRES:**

\$5 each for auto tires off the rim

\$8 each for auto tires on the rim, up to 16-inches

\$0.10 per lb. (for 4 or more tires)
