The Town of Ludlow Vermont is seeking BIDS/PROPOSALS from qualified contractors for:

### LUDLOW SKATE PARK DEMOLITION AT DORSEY PARK

*The Town of Ludlow requests bids for the demolition and removal of all wood and concrete features plus an additional 7000 square foot asphalt surface at Dorsey Park. Bids are due no later than 10:00 am on Wednesday September 28, 2022 and the demolition can begin as soon as the contract is approved by the Select Board.*

#### **Demolition of the asphalt section of the Ludlow Skate Park**

- Demolition, removal, and disposal of approximately 7000 sq ft of asphalt surface of 2” - 3” thick material.
- Demolition and removal of all wood and concrete features.
- Bidder is also responsible to remove everything off of the job site at the conclusion of the work.
- This project is cost sensitive and all bidders are encouraged to suggest cost-saving alternatives.
- Completion date will be no later than November 30<sup>th</sup>, 2022
